- The Brown County Agricultural Society (Ag Society) hereby leases to the above named Lessee the following buildings and grounds of the Brown County Fairgrounds located at 1201 North State Street in New Ulm, Minnesota. Lessee should draw a line through and initial any buildings listed that will not be used and adjust the rent accordingly.

- Exact rental rates can be obtained from Fairgrounds Manager.
- Participants and Family only, not for public attendance
- Terms of this agreement will begin and end as noted above unless sooner terminated by either party as agreed upon at the initiation of this agreement.
- The Ag Society and Lessee agree that the Lessee will deposit with the Ag Society the sum indicated above as security for its use of the leased premises under this agreement. Rental fee to be to the **Brown County Agricultural Society** paid prior to set-up.
- Lessee may not assign or sublet or permit the leased premises to be used by others without the Ag Society's prior written consent in each instance.
- The Ag Society and Lessee agree that the Ag Society will be responsible for repair and maintenance of the leased premises. The Lessee is responsible for the repair and damage caused to the leased

premises for the duration of this lease and pertaining to the portions of the fairgrounds that are covered under this lease, excluding natural disaster.

- Lessee must, at their expense, provide and maintain property insurance during the term of this agreement in an amount sufficient to cover all items of property owned, maintained and controlled by the Lessee on the leased premises.
- All insurance policies or riders required by this Agreement
  - must be taken out by the Lessee and maintained with responsible insurance companies organized under the laws of one of the states of the United States of America and qualified to do business in the State of Minnesota,
  - must contain a provision that the insurer may not cancel or revise coverage hereunder without giving written notice to Lessee as an insured party and to the Ag Society as an additional insured party at least 30 days before cancellation or revision becomes effective,
  - must name Lessee as an insured party and the Ag Society as additional insured, must be in accordance with specifications approved by the Ag Society,
  - must be evidenced by a **Certificate of Insurance** listing the Ag Society as an additional insured which must be filed with the Ag Society prior to commencement of the term of this Agreement.
