In consideration of being permitted to enter for any purpose the restricted area (here in, defined the area to which admission to the general public is prohibited, including but not limited to the pit area, racing surface, and infield, including walkways, concessions and other appurtenances therein) each of the undersigned for themselves and personal representatives, assigns, heirs and next of kin, agrees and on the direct representation that participants has or will, prior to the inception of the racing program, inspect such restricted area, constitute an acknowledgement that participant has inspected the restricted area and that it is safe and reasonably suited for the purpose of the racing program.

1. Hereby releases, waives, discharges and covenants not to sue the Promoter, Participants, Brown County Agriculture Society, Track Operator, Track Owner, Land Owner and each of them their officers, and employees, all for purposes herein referred to as releases from liability to the undersigned, participants personal, representatives, assigns, heirs, and next of kin for all damages, and any claims or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of releases or otherwise while the undersigned is upon restricted area, and

2. Hereby agrees to indemnify and save and hold harmless the releases and each of them from any loss, liability, damage or cost they may incur due to the presence of the undersigned in or about the restricted area and whether caused by the negligence of the releases or otherwise.

Each of the undersigned expressly agrees that the forgoing release, waiver an indemnity agreement is intended to be as broad and inclusive as permitted by the law of the state in which the race is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect

Each of the undersigned warrants the following statements are true and correct and understands that the releases have relied on them in entering into the following foregoing release, waiver and indemnity agreement and in giving the undersigned permission to enter into the restricted area

1. No oral representations, statements or inducements apart from the foregoing written agreement have been made
2. Participant assumes full responsibility and risk of bodily injury, death, or property damage due to the negligence of releases or otherwise upon entering the restricted area
3. Participant has read and understands the rules for eligibility and voluntarily signs this release and waiver of all liability and indemnity agreement
4. The participant holds Brown County Fair (Brown County Ag. Society) harmless with respects to bodily injury to minor children and/or guests & pit crew of the participant
